


Symbiotic combination of assets

The composition of En+ Group's assets and operations, both in terms of the industries and geographies, enables it to achieve strategic synergies. This allows the Group to optimise capacity utilization and maximise efficiency at smelters, refineries and generating

Moreover En+ Group is the only vertically integrated aluminium company able to fully meet its own hydropower and alumina needs as well as having a c. 80% self-sufficiency in bauxites and nephelines, which represent two-thirds of our costs.

Net Zero


On January 18, 2021, En+ Group announced its ambition to become net zero by 2050 and to reduce greenhouse gas emissions by at least 35% by 2035 (Scopes 1 & 2 against a 2018 baseline). On September, 2021, En+ Group published its Pathway to Net Zero Report, which comprehensively details the initiatives being undertaken across the Group to achieve its climate targets.
